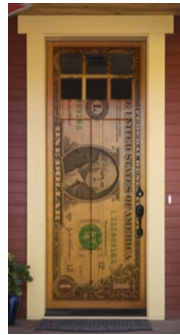


2022 Homeless Veteran & Toys for Tots Service Projects
